Specifications for bus for which bid is to be called is as under:-

- 1- The bus should be of 25 to 32 seater capacity.
- 2- The bus should be air conditioned.
- 3- The bus should have ABS for safety purposes
- 4- The bus should have BSIV standards marks.
- 5- The bus should have foldable ramp on rear side to shift wheel chair in bus.
- 6- The fabrication diagram should be attached having the list of features attached herewith excluding LED TV. The time for supply of bus with complete fabrication in all respects will be one week.
- 7- Quality fabrication should be of good quality to be approved by a govt certified body.
- 8- The tender can be cancelled without assigning any reason by the competent authority i.e. Red Cross Society Panchkula.
- 9- The bids in sealed envelope should reach the office of the undersigned on or before 4.8.17 up to 2:00 pm and the same would be opened on 4.8.17 at 3:00 pm in the presence of Addl. Deputy Commissioner in his office i.e. Room No 208, Mini Secretariat Panchkula.
- 10- The suppliers should possess GST number as per govt instructions.
- 11- The features for fabrication and seating plan in the inner side of the bus is uploaded for reference on the website of Panchkula District i.e panchkula.nic.in and has also been affixed on the notice board placed in District Red Cross Society, Sector 15, Panchkula.
