

Term and Condition:-

A. Food arrangement:- Juice, Water Bottle 100ml, Banana, Biscuit, (Per Piece)

I. Breakfast :- Allo Puri/Chole Puri/Chole Bhatoure/Bread Pakoda/Stuffed Prantha /Sandwich and Tea (Per Plate)

II. Lunch:- Rice, Chapati, Mix Veg Sessional. Dal, Salad, Rajma and Kadi Rice, Raita, Pickle (Per Plate).

III. Evening :- Tea/Milk & Buscuit Packet (10)

IV. Dinner:- Rice, Chapati, Mix Veg Dal, Salad, Sweet dish (Per Plate).

1. The service provider will have to arrange the serving of food by installation of tentage at 5 to 6 sites at the venue at his own expense.
2. All the arrangements for preparing food and snacks items will be done by the person submitting the tender which include, cooking gas and light arrangement at night for threedays alongwith generator and tentage etc.
3. The Authority invites Two Envelop tenders.G S T number is mandatory.
4. Tenders received after closing date & time shall be rejected.
5. In case the Commercial Bid and the technical bid are enclosed in the same envelope in an open condition instead of in two separate sealed/closed envelopes, such bid shall be rejected.
6. Corrections, if any, should be duly authenticated with full signature of the authorized signatory, failing which such bids are liable to be rejected.
7. The tender should be submitted neatly and all corrections, over typing should be attested with seal and full signature. Unsigned bid are liable to be rejected.
8. In the event of default in service, the right to cancel the order and to claim damages from the successful bidder by for fetching the EMD amount.
9. Conditional tender shall not be considered.
10. The rate to be quoted should be per day per item for 3 days.
11. The Supplier will be responsible himself for the custody and safety of items supplied by him.
12. The tender in two forms shall be submitted in sealed envelopes in the name of Deputy Commissioner, Panchkula.
13. The Deputy Commissioner, Panchkula reserves the right to accept or reject any one/partially or all the tenders without assigning any reason.
14. The tender shall be accompanied by earnest money of Rs. 20,000/- (Rupees Twenty thousand) in favour of DPC, SSA/RMSA, Panchkula for each item.
15. Successful tender shall deposit a sum of Rs. 1,00,000/- (Rs. Once Lac) in the shape of Cheque only as security money within Two days for the items food arrangements bedding and tentage. Earnest money 20,000/- will be counted towards security money in case of successful tenderer.
16. If successful tenderer fails, neglects, declines or otherwise not executing the same in time and in accordance with the terms of the contract, The Deputy Commissioner, Panchkula CWSN Sports organizing committee shall be at liberty to arrange all such items from open market and any excess cost so incurred over the contract price shall be recoverable/Security forfeited from successful tenderer.
17. Special focus on hygiene in case food item food items preference be given having FSSI License and other items shall be good quality in case of any laps on the part of tenderes proceeding be initiated against the service provider and Security will be forfeited
